TODAY'S MARKET REVIEW

The stock market continued the bullish trend for the four consecutive sessions as the excited investors were active on the bank sector stocks. The morning positive vibe persisted till the end amid some volatility in the session. The investors' sentiment regarding the market stayed positive as some investors took position especially in bank, engineering and financial institutions sectors stocks. However, the shaky investors opted to book some quick gain on cement, textile, pharma, telecom and fuel & power sectors stocks. Turnover stayed flat over last session as the investors remained cautious about fresh investment ahead of national election. Textile sector continued to dominate the turnover chart where 'Z' category stocks seized the top gainer list. At the days end, the DSEX and DS30 added 15.68 points and 2.07 points respectively while the DSES lost 3.69 points to their previous day's level.

The major sectors witnessed mixed performance today. Among the major sectors based on market capitalization – bank (1.4%), engineering (0.5%) and financial institution (0.4%) sectors achieved price appreciation while cement (-2.2%), textile (-0.5%) and pharma (-0.5%) sectors witnessed price correction in the day's session. The investors' activity was mostly centered on textile (26.5%), pharma (15.4%) and engineering (13.6%) sectors while DSSL (4.9%), BRACBANK (3.8%) and PTL (3.4%) led the scrip wise turnover board today.

The port city bourse, CSE increased by 52.19 points in its broad based index - CASPI.


MEGHNACEM: The Company has informed that it has credited the bonus shares for the year ended on June 30, 2018 to the respective shareholders' BO Accounts.


