
The benchmark index, DSEX, of the Dhaka bourse witnessed correction for the last three consecutive sessions and lost 65 points as the investors continued trading with cautious stance ahead of national election. The optimistic investors decided to take positions in sector specific stocks from the beginning of the session to pull up the market from the recent bearish trend. However, selling of shares in textile, fuel & power, telecom and financial institution sectors to escape from further losses in the portfolios pushed down the DSEX to close below 5,300 marks. Meanwhile, turnover has increased by 10% over last session as the investors went for buoyancy in the bank sector stocks in the final hour. Top gainer, loser and turnover lists were comprised mainly from small cap stocks. At the day's end, the DSEX, DSES and DS30 lost 10.53 points, 2.27 points and 5.98 points respectively to their previous day's

TODAY'S MARKET REVIEW

The major sectors witnessed correction today. Among the major sectors based on market capitalization – textile (-2.0%), fuel & power (-1.4%) and telecom (-0.7%) sectors witnessed price correction while tannery (1.5%), food (1.0%) and bank (0.2%) sectors achieved price appreciation in the day's session. The investors' activity was mostly centered on pharma (24.3%), textile (19.1%) and engineering (10.6%) sectors while WATACHEM (3.7%), SQURPHARMA (3.6%) and KPCL (3.0%) led the scrip wise turnover board today.

The port city bourse, CSE decreased by 53.93 points in its broad based index –




