## TODAY'S MARKET REVIEW

The prime index of the Dhaka Stock Exchange observed correction in the second day in a row amid increased investors' participation. The prime index was in positive side in the major part of the day, but last hour selling spree wipes out the early gains. The investors' propensity towards profit booking on bank, telecom and financial institution sectors' stocks took the market in the negative territory. Some investors shifted their holding to life insurance, textile and engineering sectors' stocks. Investors' participation was the highest after July 22, 2018 as optimistic investors continued to inject fresh funds into the market anticipating optimistic year-end earnings and dividend declaration. Top ten traded stocks captured around 38.1% of the day's total turnover, ACTIVEFINE seized 8.1% of the day's total turnover. At the day's end, DSEX, DS30 and DSES lost 9.7 points, 6.3 points and 3.9 points respectively to their previous day's level.

The major sectors displayed mixed performance today. Among the major sectors based on market capitalization – bank (-0.7%), telecom (-0.5%), and financial institution (-0.4%) sectors witnessed correction while life insurance (4.5%), textile (1.8%) and engineering (1.1%) sectors edged higher in the day's session. The investors' activity was mostly focused on engineering (22.4%), fuel & power (16.0%) and textile (15.5%) sectors while ACTIVEFINE (8.1%), KPCL (6.1%), and BBSCABLES (5.2%) led the scrip wise turnover board today.

The port city bourse, CSE decreased by 20.82 points in its broad based index - CASPI.
