TODAY'S MARKET REVIEW

The benchmark index of Dhaka Stock Exchange witnessed price correction amid low participation of the investors. In line with previous session, the market started negatively and continued the downbeat vibe till the end of the session, though in the middle of the session some sign of reversal was observed. Following the recent market trend, shaky investors opted for liquidating their position from textile, financial institution, food, engineering and bank sectors anticipating further fall, while some cautious investors adopted "wait-and-see" stance. Total turnover has decreased to BDT 2,417 mn which is the third lowest in this year. The top gainers list was dominated by mutual funds while the losers list was dominated by small cap stocks. At the day's end, the DSEX, DSES and DS30 lost 14.9 points, 3.7 points and 2.9 points respectively to their previous day's level.

Major sectors witnessed correction today. Among the major sectors based on market capitalization – textile (-0.9%), financial institution (-0.7%), food (-0.6%), engineering (-0.4%) and bank (-0.3%) sectors witnessed price correction while mutual fund (2.7%) and travel (0.5%) sectors achieved price appreciation in the day's session. The investors' activity was mostly centered on pharmaceutical (16.7%), bank (13.6%) and engineering (12.1%) sectors while SALVOCHEM (3.5%), QUEENSOUTH (3.3%) led the scrip wise turnover board today.

The port city bourse, CSE decreased by 22.96 points in its broad based index – CASPI.




